



**AUDIO/VISUAL CONTRACT AGREEMENT**

[ ] Commercial

This agreement shall apply in cases where the purpose is to provide visual support for a product or service and where the Production Company requesting use of the Museum may expect to derive profit from such use.

This agreement shall apply in cases where the purpose is to provide visual support for a product or service and where the Production Company requesting use of the Museum is not expected to derive profit from such use.

THIS AGREEMENT WITNESSES that in consideration of fees and covenants which the Production Company herein agrees to pay and perform, the Museum agrees to permit the Production Company to take photographs, videos of designated grounds, buildings, artifacts, equipment, chattels and items that are the possession of the Museum.

**PURPOSES OF USE**

Any filming or photography shall be used only for the purposes of:

**ALTERNATE PURPOSES OF USE**

Approval must be granted in writing by the Museum if any such material is to be used for purposes other than those stipulated above.

**LIABILITY INSURANCE**

The Museum requires \$2,000,000 in liability insurance to be carried by the production company while on site.

**PRODUCTION CREDIT**

The WDM reserves the right to request credit or be connected with the completed product, depending on end use, content and reference checks. The following production credit for use of the Museum will be used:

**LIMITED USE OF PREMISES**

The Museum shall restrict the filming/photography locations to the following areas:

**LIMITED USE OF ARTIFACTS**

The Museum shall restrict the use of Museum extension artifacts for filming/photography to the following:
